## SUBJECT DESCRIPTION

This course consists of two modules, one of which is related to health legislation, and the other with bioethics. The purpose of the legislation module is to equip students with the knowledge and skills required to manage the basic concepts and tools used in management.

The Bioethics module is intended to offer knowledge and prompt reflection on the different bioethical problems that students will face during their professional practice, and that affect different stages of patients' lives, with the resulting impact both individually and socially.

As healthcare becomes more technologically complex, healthcare professionals are increasingly subject to new questions about how ethical their actions are. This course is intended to encourage students to reflect and take a personal stance. This course consists of two modules, one of which is related to healthcare legislation, and the other to bioethics. The purpose of the legislation module is to equip students with the knowledge and skills required to manage the basic concepts and tools used in management.

questions about how ethical their actions are. This course is intended to encourage students to reflect and to take a personal stance in such circumstances, without disregarding unconditional respect for the dignity of the person. Every act of healthcare is a moral act.

## SKILLS

### Basic / general / cross skills

Students must have demonstrated knowledge and understanding in an area of study that is founded on general secondary education. Moreover, the area of study is typically at a level that includes certain aspects implying knowledge at the forefront of its field of study, albeit supported by advanced textbooks

Students must be able to apply their knowledge to their work or vocation in a professional manner and possess skills that can typically be demonstrated by coming up with and sustaining arguments and solving problems within their field of study

Students must have the ability to gather and interpret relevant data (usually within their field of study) in order to make judgments that include reflections on pertinent social, scientific or ethical issues

Students must be able to convey information, ideas, problems and solutions to both an expert and non-expert audience

Students must have developed the learning skills needed to undertake further study with a high degree of independence

To be familiar with the Spanish ethical and deontological code of nursing, and to understand the ethical implications of health in a changing world.

To be familiar with the principles of healthcare and socio-healthcare funding, and to suitably use the resources available.

To develop a learning ability and an attitude of personal development for problem-solving and decision-making.

Capacity for oral and written communication and expression.

To acquire and commit oneself to ethical values.

To understand people without prejudice taking into consideration their physical, psychological and social aspects and to see them as autonomous and independent, ensuring their opinions, beliefs and values are respected and guaranteeing their right to intimacy through confidentiality and professional secrecy.

To promote and respect the right to participation, information, autonomy and informed consent in the decision-making of patients in line with how they experience their health-illness process.

### Specific skills

To be familiar with the Spanish healthcare system.

To identify the characteristics of the management duties of the nursing services and care management; to be familiar with and be able to apply group management techniques.

To be familiar with applicable legislation and the ethical and deontological code of Spanish nursing, based on the European code of ethics and deontology in nursing.

To provide care ensuring the right to dignity, privacy, intimacy, confidentiality and decision-making capacity of patients and families. To provide customised care taking into consideration age, gender, cultural differences, ethnic origin, beliefs and values.

To be familiar with the principles of healthcare management and funding and to develop a capacity to work effectively, making good use of the resources available while always focussing on the well-being of the patient.
