SUBJECT DESCRIPTION

Esta asignatura se articula como una indagación sobre el alcance y la validez de esta hipótesis: "La comunicación es el medio natural y decisivo por el que el que cada persona logra introducirse y participar en el mundo humano"; cuyo primer corolario es: "la buena o mala comunicación condicionan radicalmente las posibilidades del desarrollo personal y social". Dado que la vida del que se formula esa pregunta queda comprometida en su respuesta, cada etapa de la indagación ha de tener un marcado carácter existencial. La primera etapa exige repasar el estado de la cuestión de la disciplina; la segunda, definir fenomenológicamente algunos conceptos fundamentales; la tercera, proponer criterios para la praxis comunicativa y para su análisis crítico; la última, repasar los grandes géneros de la comunicación social.

To acquire an ability to define research topics that may contribute to raising the awareness of audio-visual media and to appropriately set out the findings of the research in line with the standards and norms of information and communication disciplines.
