# SUBJECT DESCRIPTION

En 1993 surge en la Universidad Francisco de Vitoria el primer proyecto educativo en el ámbito universitario europeo, que integra en sus programas de Grado una asignatura obligatoria "Educación para la responsabilidad social" con el objetivo de formar estudiantes que piensen, decidan y actúen guiados por su propia responsabilidad personal y compromiso social.

La asignatura ha sido concebida para contribuir a la formación integral (técnica y humanística) de los universitarios, dada la importancia de la dimensión social en las consecuencias y repercusiones de toda acción humana. Se desarrolla mediante metodología experiencial basada en cuatro actividades nucleares: clases presenciales, prácticas en instituciones sociales, programa de acompañamiento y tutorías.

Hoy más que nunca, en un mundo globalizado y lleno de contrastes, necesitamos profesionales comprometidos y socialmente responsables, que estén dispuestos a aportar soluciones concretas frente a las situaciones de injusticia social.

#### **Basic Skills**

Students must have demonstrated knowledge and understanding in an area of study that is founded on general secondary education. To understand the dynamics of personal development through skills in communication, research, critical and creative thought, consideration and execution of action plans, and teamwork in the academic and professional spheres.

To be able to apply group work with common objectives, fostering the analysis and pooling of various approaches.

To be able to carry out projects and work using the pertinent techniques and methodology.

### Specific skills

To discover the anthropology implicit in all human actions and sciences and to analyse it critically: what is the underlying concept of mankind existing in the various theories and what are the practical, personal and social implications?

To analyse and be familiar with the organisation, operation and challenges of the United Nations.
