SUBJECT DESCRIPTION

This course is part of the Public Law module and is a core feature of the teaching of Law. The Constitution provides the basis of the legal system, a pivotal rule with an axiological and organisational content that, as the supreme law and main source of our legal system, influences both public law and private law. Political Law I deals with the formation and origin of the State, the Constitution and the democratic and political system that governs the Constitution of 1978 and the sources of Law.

SKILLS

To be able to approach a subject by means of rigorous, profound and comprehensive thought, with capacity for analysis and synthesis.

To reflect on one's learning with self-criticism, identifying areas for improvement based on criteria of quality and excellence.

To use feedback.

To develop skills for legal oratory and to be able to express oneself suitably before an audience.

To read and interpret legal texts.

To show sensitivity to fundamental human rights.
