SUBJECT DESCRIPTION

Es una asignatura troncal, obligatoria, de contenido general y relevante para el resto de asignaturas en el Grado de Derecho en tanto que la materia impartida pretende asentar las bases y fundamentos necesarios que permitirán al alumno la comprensión y el desarrollo formativo sobre las relaciones interpersonales desde la perspectiva patrimonial sin obviar que la relación obligatoria se expande a conductas de todo orden y naturaleza cuyo cumplimiento le es exigido a la persona por el ordenamiento jurídico. Así, y como futuros juristas, se pretende que los alumnos alcancen un conocimiento óptimo del derecho y una visión interdisciplinar de los problemas jurídicos, planteándose la aplicación de la norma al ideal de Justicia entendiendo que el Derecho es un instrumento para la resolución de conflictos.
