## SUBJECT DESCRIPTION

<p>Esta asignatura forma parte del Derecho Civil Patrimonial, junto con el Derecho de Obligaciones y contratos, por lo que es conveniente que el alumno haya cursado y alcanzado las competencias de la asignatura de Teoría General de las Obligaciones y Contratos y la correspondiente a los Contratos en particular.</p> <p>Con esta asignatura se pretende profundizar en las instituciones principales del Derecho de cosas, los derechos reales. En concreto, conceptos como la posesión y la propiedad, y los derechos reales limitativos del dominio: de uso, garantía, adquisición preferente (usufructo, servidumbres, hipoteca, superficie, retracto...), son fuente de conflictos permanentes en nuestra sociedad, en cuanto suponen la atribución de los bienes al hombre.</p>

Lo que se pretende con esta asignatura es que el alumno, además del conocimiento técnico de la materia que ocupa el contenido de la misma, advierta las consecuencias no sólo jurídicas e inmediatas que conllevan, sino la dimensión que alcanzan en el devenir de las relaciones interpersonales más cotidianas y el papel que desempeñan dentro del sistema económico y patrimonial.

Por último, se analiza la publicidad de los Derechos reales a través del Registro de la Propiedad, y el juego de los principios registrales.
