SUBJECT DESCRIPTION

El contrato es el instrumento que permite a personas físicas y jurídicas conseguir aquellos bienes o servicios que les son necesarios para el desarrollo de su actividad cotidiana. Figuras jurídicas como el contrato de compraventa, los arrendamientos urbanos o el contrato de obra, por enumerar algunos de los más utilizados, y de mayor influencia, son objeto de estudio en esta asignatura. De ahí que su objetivo sea que el alumno conozca el contenido de las relaciones contractuales más habituales en Derecho privado, civil y mercantil, así como la importancia de los acuerdos alcanzados entre las partes, sus limitaciones y las consecuencias que se derivan de su conclusión. Además de alcanzar los conocimientos jurídicos necesarios, el alumno también deberá desarrollar un criterio de solución de los problemas derivados de la contratación desde una perspectiva humanista adaptada

a las realidades actuales de la contratación (globalización, inteligencia artificial aplicada, etc.)
