SUBJECT DESCRIPTION

El Derecho Administrativo II, que se engloba dentro del módulo de Derecho Público del Grado en Derecho, constituye la parte especial de la asignatura. Dentro de su temario se incluye el estudio de las potestades expropiatoria y sancionadora; la contratación pública; el régimen jurídico básico del patrimonio de las Administraciones Públicas (bienes de dominio público, patrimoniales, comunales, patrimonio nacional) y el control jurisdiccional de la actuación de las Administraciones Públicas (proceso contencioso-administrativo). En el tema correspondiente a contratación pública se estudiará, además, el sistema de contratación pública de otros países de nuestro entorno desde la perspectiva del Derecho Comparado.
