## SUBJECT DESCRIPTION

<p>Esta asignatura comprende el estudio tanto del régimen general de extranjería, como de regímenes particulares aplicables a determinados colectivos: el régimen comunitario, aplicable a los ciudadanos de la UE o del Espacio Económico Europeo; el derecho de asilo de los refugiados y el régimen aplicable a los apátridas.</p> <p>Tiene una enorme trascendencia práctica, no solo por el volumen de extranjeros que se encuentran (de modo legal o irregular) en territorio español, y que precisan asesoramiento jurídico, sino principalmente porque afecta al estatuto jurídico propio de la persona como tal y no solo como trabajador, comprendiendo dicho estatuto tanto derechos como obligaciones.</p>

El Grado en Derecho de la UVF aspira a formar juristas con un sólido respeto por la persona humana. Por ello en esta asignatura se presta especial atención a la definición de extranjero como "persona que no ostenta la nacionalidad española", teniendo presente que la "persona" en su condición de extranjero tiene no solo una inherente dignidad, sino el derecho a la protección de la misma, lo que tiene plasmaciones concretas, por ejemplo, en el ámbito de la reagrupación familiar. No perder de vista esa dimensión personal permitirá un mejor y más completo asesoramiento jurídico al extranjero.
