SKILLS

Basic Skills

Students must have demonstrated knowledge and understanding in an area of study that is founded on general secondary education. Moreover, the area of study is typically at a level that includes certain aspects implying knowledge at the forefront of its field of study, albeit supported by advanced textbooks

Students must be able to apply their knowledge to their work or vocation in a professional manner and possess skills that can typically be demonstrated by coming up with and sustaining arguments and solving problems within their field of study

Students must have the ability to gather and interpret relevant data (usually within their field of study) in order to make judgments that include reflections on pertinent social, scientific or ethical issues

Students must be able to convey information, ideas, problems and solutions to both an expert and non-expert audience

Students must have developed the learning skills needed to undertake further study with a high degree of independence

General Skills

To be familiar with the characteristics defining an efficient psychology professional: up-to-date professional knowledge (knowing how to select and manage information in both Spanish and other languages, especially English), critical thinking, ethics, personal integrity and social commitment to universal and democratic values.

To be familiar with the foundations of ethics and professional deontology.

Cross Skills

An ability to develop one's abilities, skills and knowledge according to professional standards and to keep them up-to-date.

Ethical commitment and social improvement.

An ability to adapt to new situations.

To show a commitment to quality in one's actions and to be able to develop systems to ensure the quality of the services one provides.

To nurture an attitude of intellectual curiosity and a quest for the truth in all areas of life.

To identify the process of personal accomplishment and the goals to be attained by organising a plan of action to this end.

To forge attitudes of respect, tolerance and dialogue with regard to other cultures and religions in the search for the truth.

An ability to take on responsibility and make decisions.

Capacity for disciplinary and interdisciplinary teamwork.

Specific skills

To be familiar with the laws governing the profession in the various areas of psychology.

To be familiar with and fulfil the deontological obligations of professional psychology.

To be familiar with the basic issues of ethics and bioethics: importance, assumptions and contributions; bioethics committees.

To perceive the individual as an entirety in holistic terms, distinguishing aspects of said individual: biological, psychobiological, social and existential.
