#### SUBJECT DESCRIPTION

It is a reflection on the meaning of human existence, of man as a naturally religious being and on the importance of the religious fact in human biography and culture. It seeks to understand the possible relationship between faith and reason, to obtain basic knowledge of the comparative history of religions, to assess the importance of religious freedom and tolerance and, in particular, to know the biblical faith in its sources and the foundations of Christian doctrine.

Work on the question of the ultimate meaning of life, which leads us to the question of God, and examine the most common answers to this problem in the fields of science, reason (philosophy) and religious faith (theology), as well as the implications that follow from it for 21st century man, especially the student or future professional of the Degree in which the subject is taught.

The specific aims of the subject are:

To ask the ultimate question of human existence.

Analyze the religious dimension of man in connection with the meaning of existence.

Understand where the possibility of relationship and dialogue between men comes from.

Distinguish some of the most important religious worldviews.

Ask yourself about the Christian fact and analyze the historical claim of the man Jesus of Nazareth.

INTRODUCTION AND JUSTIFICATION OF THE SUBJECT (Proposed content: Reason and meaning of the Introduction to Theology. Why is it important? What is the horizon we are heading to? What path are we going to take? Fundamental Concepts: Reason, Faith, Transcendence, Man and the Question of God, Natural Theology and Theology of Faith).

#### LEARNING APPRAISAL SYSTEM

Written development and/or test-type tests: 80%. To pass the course, students are required to obtain a minimum score of 5 out of 10 (or equivalent) in all theoretical exams. Individual and/or group work and exercises: 20%.

If appropriate and at the discretion of the teacher, an honorary enrollment (for every 20 enrolled students) will be awarded to those students who have obtained at least 9 as a final grade of the course and who have shown a particularly significant performance both in results and in their attitude in class.

The extraordinary call will be resolved according to two types of exercises, whose specificity and percentage will be the responsibility of the teacher who teaches the subject in each group. In general, it will always move within the following parameters: Theoretical exams: 80%. Other exercises: 20%.

Plagiarism, as well as the use of illegitimate means in evaluation tests, will be sanctioned in accordance with the university's Evaluation Regulations and Coexistence Regulations.

# ETHICAL AND RESPONSIBLE USE OF ARTIFICIAL INTELLIGENCE

1.- The use of any Artificial Intelligence (AI) system or service shall be determined by the lecturer, and may only be used in the manner and under the conditions indicated by them. In all cases, its use must comply with the following principles:

a) The use of AI systems or services must be accompanied by critical reflection on the part of the student regarding their impact and/or limitations in the development of the assigned task or project.

b) The selection of AI systems or services must be justified, explaining their advantages over other tools or methods of obtaining information. The chosen model and the version of AI used must be described in as much detail as possible.

c) The student must appropriately cite the use of AI systems or services, specifying the parts of the work where they were used and describing the creative process followed. The use of citation formats and usage examples may be consulted on the Library website(<u>https://www.ufv.es/gestion-de-la-informacion\_biblioteca/</u>).

d) The results obtained through AI systems or services must always be verified. As the author, the student is responsible for their work and for the legitimacy of the sources used.

2.- In all cases, the use of AI systems or services must always respect the principles of responsible and ethical use upheld by the university, as outlined in the <u>Guide for the Responsible Use of Artificial Intelligence in Studies at UFV</u>. Additionally, the lecturer may request other types of individual commitments from the student when deemed necessary.

3.- Without prejudice to the above, in cases of doubt regarding the ethical and responsible use of any AI system or service, the lecturer may require an oral presentation of any assignment or partial submission. This oral evaluation shall take precedence over any other form of assessment outlined in the Teaching Guide. In this oral defense, the student must demonstrate knowledge of the subject, justify their decisions, and explain the development of their work.
